


2002 - 2003 Annual Report

he Mackenzie Valley Resource Management Act (MVRMA) came into force on December 22, 1998 and established the MVEIRB as the agency to undertake environmental assessment and review in the Mackenzie Valley.

The Board's jurisdiction applies to all lands in the Northwest Territories, excluding the Inuvialuit Settlement Region and Wood Buffalo National Park. The MVRMA replaces the Canadian Environmental Assessment Act (CEAA) in the Mackenzie Valley except under very specific circumstances.









Message from the Chair

This past year has brought many changes at MVEIRB. A turnover in staff provided the opportunity for us to recruit new talent into our organization resulting in an even stronger team of professionals. Mr. Martin Haefela and Ms. Sherry Sian, our new Environmental Assessment Officers joined our organization and brought with them combined experiences ranging from the corporate boardroom to the community council chambers.

Commitments from the Minister of Indian and Northern Affairs Canada to provide secure core funding and to respond quickly to additional resource needs have allowed us to focus on our main business, doing quality environmental assessments. As well, the Minister committed to establishing the position of Chair as a full-time position. This is a first for the Northern boards.

At the operational level, we have implemented project-tracking techniques to assist us with planning, execution and monitoring of our projects. Adopting a lessons-learned approach after the conclusion of each assessment means that we continue to improve the efficiency and quality of our work.

In addition to the day-to-day activities associated with conducting our assessments, the Board and Staff have made considerable progress in developing guiding documents designed to assist both the parties to our processes and the environmental assessment practitioners. Such undertakings include a groundbreaking translators workshop that provided participants with a better understanding of the overall process as they developed the literal translation of the various terms used in the regulatory and environmental assessment process.

As we move forward into 2003, the workload for MVEIRB continues to increase. However, the talent in our organization combined with the commitment of necessary resources have positioned the MVEIRB to meet the new challenges head-on and provide the quality of service that the people of the North and Canada deserve.

Staffing and Location

The MVEIRB's office is located on the second floor of the Scotia Centre in Yellowknife. The staff consists of an Executive Director, three Environmental Assessment Officers, a Finance and Administration Officer, a Traditional Knowledge Coordinator, a Communications Officer and an Administrative Assistant.

The Board hired Mr. Martin Haefele and Ms. Sherry Sian as Environmental Assessment Officers in January to replace two departing staff members.









Preliminary Screenings

In the period from April 1, 2002 to March 31, 2003, the Board received 157 notifications of preliminary screenings. This is down from the 220 screenings received the previous year and the 186 screenings received in fiscal year 2000-2001. Please refer to the end of this report for a summary list of this year's preliminary screenings.

Environmental Assessments

DeBeers Canada Mining Ltd.'s Snap Lake underground diamond mine development was referred in May, 2001. The target date for completion is June 2003. As part of this environmental assessment MVEIRB held a technical session from November 25 to December 6, 2002.

WesternGeco Ltd.'s Mackenzie and Liard Rivers seismic survey was referred jointly in June 2002 by the Department of Fisheries and Oceans and the National Energy Board. The environmental assessment was put on hold pending completion of the company's test program. It was reinstated in December, 2002 at the request of the company.

The Sahtu Land and Water Board referred the Northrock Resources Ltd. Summit Creek exploratory oil and gas well to environmental assessment in March, 2003. This is the first referral out of the Sahtu region for the MVEIRB.

Other Environmental Assessments

Canadian Zinc Corporation's decline and metallurgical plant was referred April, 2001 and completed January, 2002. The environmental assessment report was returned to MVEIRB by the Minister of Indian and Northern Affairs Canada for reconsideration in September, 2002. The Board submitted its reconsideration to the Minister on April 4, 2003.

The Northern Rivers Survey Ltd. aquatic seismic survey of the Liard and South Nahanni Rivers was put on hold at the request of the company in October, 2002 pending the completion of a test survey by the company. NRSL has the option of reactivating the environmental assessment once this test survey is completed.

The Mackenzie Valley Land and Water Board (MVLWB) referred the water license renewal for North American Tungsten's CanTung mine to environmental assessment. However, the company appealed this decision through the courts and this decision to refer was reversed.









MVEIRB Activities

MVEIRB members participated in 10 board meetings and 12 teleconferences during the fiscal year. The meetings were held to discuss the full schedule of environmental assessments that the MVEIRB had to deal with in its third full year of operation. MVEIRB held a regularly scheduled meeting in May in Port Hardy, British Columbia in conjunction with a site visit to the Island Copper Mine to view abandonment and restoration efforts by BHP Billiton Ltd. at its open pit site. MVEIRB held its June meeting in Norman Wells and held a community open house in conjunction with the meeting.

Strategic Planning

MVEIRB continued its strategic planning exercise initiated the previous fiscal year. MVEIRB set out its three-year strategic plan during a workshop held in December, 2002 and developed an expenditure and work plan which was geared to anticipated activity surrounding the application for a Mackenzie Valley pipeline in the 2003-2004 budget year.

MVEIRB Budget

This year's budget allocation from INAC was \$2.9 million, which allowed MVEIRB to initiate several projects outlined in its strategic plan. This marks an increase from previous years so that MVEIRB could prepare for the anticipated filing of permits for the Mackenzie Valley natural gas pipeline.

The Chair met with the Gwich'in Claims Implementation Committee in Inuvik in August, 2002 to discuss MVEIRB's budget and the ten-year review of claims implementation.

INAC provided supplementary funding to all northern boards for participation in the ongoing work of the Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee. This allowed the MVEIRB to work on this important issue without impacting greatly on its core budget.

Environmental Assessment Guidelines

MVEIRB held several meetings with its stakeholders on the revisions to Guidelines for Environmental Impact Assessment in the Mackenzie Valley. A final version will be released in the 2003-2004 fiscal year.

MVEIRB initiated work on developing an information bulletin on environmental assessment of seismic operations in the Mackenzie Valley.

MVEIRB continued work on its discussion paper on Socio-Economic Impact Assessment. This discussion paper started the process for developing guidelines on how MVEIRB will deal with this part of its mandate. Developing these socio-economic guidelines will be a public process involving different stakeholders.

MVEIRB has a seat on the Cumulative Environmental Assessment Monitoring Framework (CEAMF) comprised of various government departments and aboriginal organizations. This group has been developing the framework for defining cumulative assessment in the Northwest Territories.

Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee

A meeting initiated by the MVEIRB in December, 2000 brought together, for the first time, the Chairs of the Mackenzie Valley boards, the Inuvialuit settlement area boards, the National Energy Board, the CEAA, the GNWT and INAC to begin work on coordinating the various regulatory and environmental assessment legislation in preparation for an application to build a Mackenzie Valley natural gas pipeline. During the last fiscal year, the parties developed the Cooperation Plan that outlines how these different bodies will work together. This fiscal year saw the parties completing work on many of the initiatives outlined in the Cooperation Plan.

In September, 2002 MVEIRB, the Environmental Impact Review Board for the Inuvialuit Settlement Region and CEAA released their draft agreement for participation on a joint review panel.

MVEIRB member Mr. Frank Pope of Norman Wells is the Chair of the Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee.

Other Activities of Interest

Transboundary Cooperation Agreements

MVEIRB staff discussed cooperation agreements with other regulatory agencies and boards which operate adjacent to the Mackenzie Valley. These agreements set out how the respective agencies will cooperate with each other in dealing with transboundary environmental assessments. This is separate and different from the Cooperation Plan for a proposed Mackenzie Valley natural gas pipeline noted above. MVEIRB has discussed these cooperation agreements with the Nunavut Impact Review Board and the Environmental Impact Review Board for the Inuvialuit Settlement Region.

Traditional Knowledge

MVEIRB co-sponsored a traditional knowledge workshop in November, 2002 with INAC and MVLWB. The focus of the workshop was to bring elders together to provide some advice and direction to the boards on how traditional knowledge should be handled in the environmental assessment process.

The boards organized a three-day translator's workshop in March, 2003 to develop terms and phrases in the Mackenzie Valley aboriginal languages for words frequently used in environmental impact assessment. MVEIRB plans to continue this initiative in 2003-04.

The Next Twelve Months

MVEIRB will be conducting environmental assessments as projects are referred by the preliminary screeners. Since the referral decisions are made by other agencies, it is difficult to predict how many environmental assessments may come before MVEIRB over the next twelve months.

The information available to MVEIRB at time of application indicates that the Mackenzie Delta Producers Group will not be submitting their application for a Mackenzie Valley pipeline until late in 2003.

Work is continuing on developing a discussion paper which will guide how MVEIRB incorporates section 115 (b) of the MVRMA into its environmental assessment work. This section gives the mandate to MVEIRB for looking at socio-economic issues.

Auditors' Report

Notes to Financial Statements

March 31, 2003

1. Organization and Jurisdiction

The Mackenzie Valley Environmental Impact Review Board (MVEIRB) is established under the Mackenzie Valley Resource Management Act with a mandate to perform environmental assessments in the Mackenzie Valley of the Northwest Territories. MVEIRB is dependant upon funding in the form of contributions from Indian and Northern Affairs Canada. Management is of the opinion that if the funding was reduced or altere operations would be significantly affected.

MVEIRB is exempt from income tax under section 149(1) of the Income Tax Act.

2. Accounting Policies

The following is a summary of the significant accounting policies used by management in the preparation of these financial statements.

(a) Fund accounting

The Board uses fund accounting to segregate transactions between its operating fund and property and equipment fund.

(b) Property and equipment

Purchased property and equipment are recorded in the property and equipment fund at cost. Amortization is recorded in the property and equipment fund using the declining balance method, except for leasehold improvements which use the straight line method, at the annual rates set out in Note 7.

(c) Financial instruments

All significant financial assets, financial liabilities and equity instruments of the Board are either recognized or disclosed in the financial statements together with available information for a reasonable assessment of future cash flows, interest rate risk and credit risk.

(d) Recognition of contributions

The Board follows the deferral method of accounting for contributions. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and its collection is reasonably assured. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred.

(e) Use of estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the updated amounts of revenues and expenses during the period. Actual results could differ from those estimates.

3. Budgeted Revenue

The Board receives funding from Indian and Northern Affairs Canada for their core activities as well as for various other projects. The allocation of current year revenue is as follows:

9. Statement of Cash Flows

10. Commitments

The Board has entered into a lease agreement for its premises. The office lease expires in September, 2005 with minimum lease payments of \$74,596 per annum and estimated operating costs of \$58,141 per annum. The Board has entered into a lease agreement for office equipment. The office equipment lease is for \$1,245 quarterly and expires in October, 2005.

11. Budget

The budget presented is unaudited, and are those approved by MVEIRB's board. Budget figures do not include revenues and expenses of special projects funded by Indian and Northern Affairs Canada.

12. Comparative Figures

Certain of the prior year figures have been reclassified to conform with the current year's presentation.

13. Contingency

Most of the funding from Indian and Northern Affairs Canada consists of flexible transfer funding. Upon further review of the financial information by Indian and Northern Affairs Canada, a repayment of unspent funds may be requested. A possible repayment of funds is unknown and cannot be estimated at this time. If a repayment is requested, the adjustment will be made in the year that the request is made.

Our brand has been designed to accommodate the diverse aspects of our role in the Mackenzie Valley and our responsibility to the people, the land and the great waters that course through it. The drum is a strong aboriginal symbol depicting voices of the people, the voices of the board, the land, the animals and the environment. The small circles represent the 28 communities of the Mackenzie Valley ranging in size from big to small. The change in size also represents the transition of

life for people as they pass from youth to elder and for the changes in the sun as it passes through the seasons. Curved lines depict the river and the flow of life. Water separates the land and sky. The three lines are the people, the economy and the government, our three main influences. We have chosen colours to link us to the other comanagement boards in the region. The yellow lines also represent the resources of our land.
