

The Decision Makers in the Process

In 1998, the Mackenzie Valley Resource Management Act established a number of independent boards that were designed to run the various stages in the environmental impact assessment and regulatory processes.

Although the federal government enacted this piece of legislation, it resulted from land claim negotiations. This legislation gives Aboriginal people of the Mackenzie Valley, Northwest Territories, a greater say in resource development and management. These independent boards are co-management, which means Aboriginal land claim organizations nominate half of the board members, and the federal and territorial governments nominate the other half of the board members.

The Mackenzie Valley boards and organizations involved in the environmental impact assessment and regulatory process are as follows:

Mackenzie Valley Environmental Impact Review Board

The Mackenzie Valley Environmental Impact Review Board is responsible for conducting environmental assessments on proposed developments and for striking panels to conduct environmental impact reviews on them if necessary, throughout the Mackenzie Valley.

Based on the findings of its assessment, this co-management board makes recommendations to the federal and responsible ministers on whether a proposed development can proceed for regulatory approval or not, and if so under what conditions. This co-management board was established by the *Mackenzie Valley Resource* Management Act.

Mackenzie Valley Land and Water Board

The Mackenzie Valley Land and Water Board is responsible for conducting preliminary screenings and for regulating the use of land and water in the Dehcho and South Slave regions (unsettled claims areas), as well as development that may have impacts on more than one settlement region. The authority of this co-management board extends to all Crown and private lands and water in the Mackenzie Valley.

In the Sahtu, Gwich'in and Wek'èezhìi (settled claim areas), regional land and water boards have been established. The Mackenzie Valley Land and Water Board monitors and ensures consistent application of the *Mackenzie Valley Resource* Management Act between all regional land and water boards in the Mackenzie Valley.
