Happy New Year everyone. I thought it would be useful to start the year off with an update on the status of environmental assessments (EA). The Review Board was referred the following:

1. BHP - file 99-004. Awaiting Review Board decision.
2. CZN - file 00-002. Terms of Reference (TOR) released. Awaiting EARs from CZN. Developer is the Canadian Zinc Corporation (CZN).
3. PAR - file 00-003. Three EA's for all of Paramount's (PAR) proposed developments east of the Liard Highway rolled into one EA. Preparing Work Plan and draft TOR.
4. PAR - file 00-004 TOR and Work Plan released.
5. PAT - file 00-005 Patterson (PAT) Forestry referred to EA by the Fort Resolution Local Government. Preparing Work Plan and TOR.

Expect to receive draft TOR and work plans for 00-005, 00-003 and EARs from CZN for conformity and technical analysis. Please contact me by email or phone if you have concerns, comments or suggestions regarding any of the EA's. I will be preparing letters of EA notification for the Patterson and Paramount EA's this week. I hope you had a restful break and will have a prosperous New Year.
