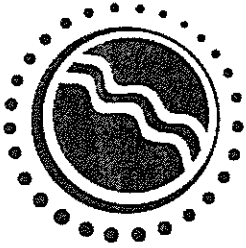

**Re: Notice of Referral to Environmental Assessment – Consolidated Goldwin Ventures Inc. Diamond Exploration at Drybones Bay (MV2003C0003)**

On April 11, 2003 the Mackenzie Valley Land and Water Board referred Consolidated Goldwin Ventures Inc.'s proposed Diamond Exploration Program to Environmental Assessment, according to section 125 of the Mackenzie Valley Resource Management Act. The Mackenzie Valley Land and Water Board cited a potential for public concern as the reason for the referral.

Consolidated Goldwin Ventures Inc. proposes to drill five holes in the Great Slave Lake west of Drybones Bay and north of Hearne Strait between February and June. Other activities associated with the proposed program include conducting additional geophysical surveys prior to drilling and establishing a mobile camp, if required, for 1-2 weeks. The development will be helicopter supported from Yellowknife. The Preliminary Screening report identified concerns involving the cultural, spiritual and environmental importance of the Drybones Bay Area.

The Review Board will initiate the scoping of the project and assessment shortly. Organizations on the distribution list will be invited to comment on a draft Terms of Reference and Work Plan. At a later date, interested parties will be asked to identify which role they intend to play during the assessment. Please indicate whether you wish to remain on the distribution list and receive further correspondence, or whether you would like to be taken off the distribution list, by faxing the attached sheet back to me.
