We have been asked by our clients to rearticulate the Ka'a'Gee Tu's request that the hearing date for the above-noted EA be moved. As they wrote in their letter to you of January 7, 2004 the dates are confirmed to conflict with the Regional Deh Cho Leadership Meeting.

The Ka'a'Gee Tu were not consulted in the process of setting these hearing dates. They resubmit their request that the hearing be rescheduled to a date that is better suited for their participation, and for the participation of others involved in the Deh Cho meetings.

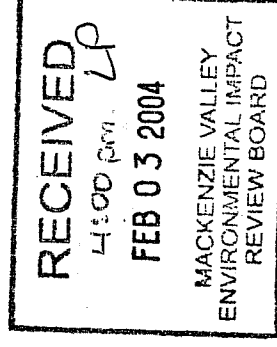
