

5.0 COMMUNITY ENGAGEMENT

The environmental assessment and development phases of a project review coincide with an effective and meaningful communications and consultation strategy. To this end, and as required by legislation, Tyhee NWT Corp believes and supports the concept that effective and meaningful communications and consultations contribute to the development of sound corporate and community relations. Further, the quality of these relationships can influence the timing of a project review associated with the public hearing process and to effectively address aboriginal concerns related to the project. This strategy has also been a component of current exploration activities and has been successful to date.

5.1 CONSULTATION AND COMMUNICATIONS PROGRAM

Tyhee NWT Corp began consultation for the YGP in 2004 and has focused its consultation efforts on the local communities potentially affected by the YGP and has held informal meetings with various regulatory agencies. The goal of Tyhee NWT Corp's consultation efforts has and continues to be one that ensures the local communities have a sound understanding of the YGP and that input is solicited during the planning phase of the project.

During the current advanced exploration phase of the YGP, consultation has been focused on providing periodic updates on the preparation of the Developers Assessment Report through correspondence with the Mackenzie Valley Environmental Impact Review Board and where appropriate to the closest affected communities (N'dilo, Dettah and Yellowknife) and with the regulatory agencies that have particular interest at the project, specifically the Contaminant and Remediation Directorate of Indian and Northern Affairs Canada, the Department of Fisheries and Oceans and the Department of Environment. Similarly, site visits by the aboriginal community have also occurred during the current advanced exploration phase of the Yellowknife Gold Project.

5.2 ABORIGINAL COMMUNITIES

The YGP lies within the shared traditional area of the Dogrib and Akaitcho First Nations, as defined in the Tlicho Agreement. Through this Agreement, the Dogrib have an informal agreement with the Akaitcho peoples to be informed of land use activities within the territory of the Tlicho Agreement.

In 2004, Tyhee NWT Corp initiated consultation with aboriginal communities. The YGP consultation involves the Dogrib, Yellowknives Dene First Nation, Lutsel K'e Dene, Deninu K'ue First Nations and North Slave Métis Alliance (NSMA). On the advice of the MVEIRB, the Northwest Territory Métis Nation was added to the consultation list in the summer of 2007.

Since 2007, consultation within the Akaitcho First Nations has been primarily with the Yellowknives Dene First Nation (in Dettah and N'dilo), as the Yellowknives Dene First Nation (YKDFN) identified that the Yellowknife Gold Project was in their exclusive

territory. Therefore, Tyhee NWT Corp has focussed its consultation efforts with the YKDFN and has, as suggested by the MVEIRB included similar discussions with the North Slave Métis Alliance (NSMA).

As a result of the economic recession in 2008 which carried over into 2009 and 2010, Tyhee NWT Corp's consultation efforts have focussed on meetings with the YKDFN economic arm (Deton'Cho Corporation) during which the Chiefs from both N'dilo and Dettah attended some of the discussions. The 2008 (including 2009 and 2010) recession also resulted in limited discussion and meetings within the communities of N'dilo and Dettah.

With the above in mind, Tyhee NWT Corp focussed on the following groups:

When meeting in the communities all arrangements have been made through the Land and Environment staff and in some cases were the only participants in the discussion, which included project updates and permit renewal applications where applicable.

Guided tours of the YGP area were carried out with the elders of the YKDFN and the NSMA in August 2005. In the fall 2006, a Traditional Land Use Study was completed for Tyhee NWT Corp by the NSMA (Appendix G). Tyhee NWT Corp's efforts to engage the YKDFN on a traditional land use study were unsuccessful. Since the activities at the YGP have remained consistent with those activities witnessed by the elders tour noted above, no further site tours involving the YKDFN or NSMA have occurred.

5.3 REGULATORY AGENCIES

Since the initial meeting with the Mineral Development Advisory Group (MDAG) in January 2005, Tyhee NWT Corp project personnel have, on numerous occasions, met with the land use inspectors of Indian and Northern Affairs Canada, the Contaminant and Remediation Directorate of Indian and Northern Affairs Canada staff and the Federal Departments of Fisheries and Oceans and Environment. Similar meetings are

planned with these departments, and possibly others, as the YGP moves through the environmental assessment process and subsequent regulatory process later in 2011. These meetings have provided an effective mechanism for information sharing and coordination between the regulatory agencies and Tyhee NWT Corp. Since that time, updates to the regulators have been carried out through communications or face-to-face meetings with the MVLWB and the MVEIRB

5.4 CONSULTATION EVENTS

Table 5.4-1 is a summary of Tyhee NWT Corp's primary consultation efforts from May 2004 to the present. A detailed communications log with aboriginal communities and regulators, including meeting notes, is provided in Appendix G.

5.5 COMMITMENTS AND AGREEMENTS

Tyhee NWT Corp has not as yet made any commitments or agreements with any group; however, we are investigating possible instruments that will give the focussed aboriginal groups an opportunity to participate in the YGP through various contracts and other business opportunities. It is expected that these discussions will occur during the environmental assessment process and continue into the regulatory phase of the Yellowknife Gold Project.

5.6 OUTSTANDING ISSUES AND RESOLUTION EFFORTS

There are no outstanding issues at this time that require resolution. Once the various agreements are in place, these agreements will of course have dispute resolution mechanisms built into those agreements.
