Re: Update to De Beers Canada Gahcho Kué EIS Information Workshops

Dear Martin,

On October 4, 2007, De Beers Canada presented the Gahcho Kué proposed project description and introduced Gahcho Kué members to parties who will be involved in the review of the Gahcho Kué Environmental Impact Statement (EIS). Two additional workshops were scheduled for October 18th and 24th, 2007 which were to be on the Gahcho Kué environmental assessment approach and initial baseline findings, respectively. A fourth workshop on high level EIS findings was planned for November 19th, 2007.

In an email sent October 15, 2007 participants were notified that the workshops planned for October 18th and 24th, 2007 had been cancelled. The Terms of Reference for the Gahcho Kué Environmental Impact Statement (the TOR) were released on October 5, 2007. De Beers is currently considering this document and focusing its efforts on preparation of the EIS. As a result the EIS workshops previously planned for this year will be rescheduled for dates in 2008. Information regarding the workshops will be provided to you in early 2008.
