

The Yellowknives Dene First Nation (YKDFN) is pleased to provide the Review Board the attached Information Requests (IRs). The YKDFN would like to express concern about the hurried nature of this environmental assessment especially given the change in the scope of assessment to include bulk sampling, the addition of a second Developer Assessment Report, and overlapping environmental assessments.

The YKDFN respectfully asks the Review Board to postpone the upcoming Snowfield prehearing conference and public hearing and so that Snowfield can benefit from the upcoming hearings for the three concurrent environmental assessments of Consolidated Goldwin Ventures, North American General Resources Corporation, and Shoshone Ventures. This will enable the proponent to benefit from the results of the hearings, provide any supplemental information and provide an opportunity for the proponent to work with the YKDFN in meaningful consultation. In addition, the public hearing is scheduled very close to Christmas and is not conducive to engaging broad YKDFN membership and public participation. Please consider this a formal request for ruling pursuant to the Review Board's rules of procedure.
