

We would like to formally withdraw our MVLWB Class "A" Land Use Permit MV2005C006 for MacInnis Lake, NT. Our board of directors feels the associated costs and unnecessary time delays associated with an environmental assessment according to section 125 of the Mackenzie Valley Resource Management Act, for the proposed grass roots exploration program at MacInnis Lake is neither in the shareholders nor the company's best interest.

Reasons for withdrawal:

Alberta Star feels that it cannot bear the cost of environmental assessment, nor be made to do so, at this early stage of the exploration process. It makes absolutely no sense whatsoever to bear such a large up front cost, prior to any sort of mineral discovery and incur this sort of expenditure. No other mining jurisdiction in Canada penalizes an exploration company trying to spend its exploration dollars in this way by mandating environmental assessment prior to any sort of exploration or discovery.
