The Gwich'in are a culturally independent Nation that is focused on protecting and advancing our interests. Through quality work, collaborative approaches, and good governance, we strive to increase economic opportunities, develop infrastructure, promote health and wellness, and preserve the culture and language of the Gwich'in.

One of the objectives of the GTC is to develop and promote economic, social, educational and cultural programs that will enable the Gwich'in to become self-sufficient and full participating members in a global society. We represent over 3,500 Participants to the GCLCA – over half of which reside in the NWT. The GTC also seeks to retain, preserve and enhance the traditional and cultural values, customs and language of the Gwich'in.

As stewards of the land and advocates for environmental sustainability, the GTC also prioritizes the protection of our natural resources, ecosystems, and cultural heritage. As such, our traditional knowledge, expertise, and perspectives are invaluable assets in ensuring that the Mackenzie Valley Highway is developed in a manner that respects environmental conservation, mitigates potential risks, and upholds our cultural values and way of life.

Therefore, we urge the responsible authorities and stakeholders involved in the decision-making process to commit to transparency, accountability, and adherence to the highest
