The Mackenzie Valley Resource Management Act (MVRMA) came into existence on December 22 1998, replacing the authority of the Canadian Environmental Assessment Act (CEAA) in the Mackenzie Valley.

The MVRMA gives the Mackenzie Valley Environmental Impact Review Board (MVEIRB) responsibility for environmental assessments and reviews in the Mackenzie Valley. Currently, the Board's jurisdiction extends across the Northwest Territories, excluding only the Inuvialuit Settlement Region and Wood Buffalo National Park.



## Message from the Chair

As a newcomer to the Review Board, I would like to start by thanking the outgoing Chair Mr. Gordon Lennie for his leadership and direction. Mr. Lennie brought this Board into existence five years ago when it began as a Working Group preparing for the passage of the Mackenzie Valley Resource Management Act. He established the Review Board as a part of the regulatory landscape of the North. Through his efforts, the Mackenzie Valley Environmental Impact Review Board is now poised to deliver quality environmental assessments for the people of the Mackenzie Valley.

## Membership

As of March 31, 2002, the Board consisted of six members: Todd Burlingame, Chair, Frank Pope of Norman Wells (who also acts as Alternate Chair on pipeline issues), Bertha Rabesca from Rae-Edzo, Charlie Snowshoe of Fort McPherson, Gordon Wray of Yellowknife (who also acts as Alternate Chair on office and administration matters) and Danny Bayha of Deline.

Originally, Mr. Burlingame was appointed to the Board by the federal government in December 2001 to replace Mr. Dennis Bevington. Mr. Bevington, as a board member, stepped down the previous August to accept a position with the Government of the Northwest Territories. After filling that position for two months, Mr. Burlingame was offered the Chair's position when Mr. Gordon Lennie's term as Chair expired. In February 2002 Mr. Burlingame was appointed Chair of the Board, leaving his previous position vacant.

The Deh Cho Interim Agreement, negotiated between the Deh Cho First Nations and the federal government, calls for further appointments from the Deh Cho to the Mackenzie Valley Environmental Impact Review Board. Although these appointments were expected to be filled during this fiscal year, it is likely their completion will occur in the 2002-2003 fiscal year.

## Staffing and Location

The Board's offices are located on the second floor of the Scotia Centre in Yellowknife, NT. The staff consists of an Executive Director, Board Secretary, three Environmental Assessment Officers, a Finance and Administration Officer, a Traditional Knowledge Coordinator and a Communications Officer.

The Review Board appointed Mr. Vern Christensen as its Executive Director in May 2001. Mr. Christensen brings many years of administrative experience to the Board. Most recently he served as an Assistant Deputy Minister of the Department of Municipal and Community Affairs for the Government of the Northwest Territories. Other new additions to the Board include Mr. Joe Acorn and Mr. Alan Ehrlich who were both hired as Environmental Assessment officers in July; Ms. Susan Hunt was employed as Board Secretary in October; and Ms. Karen MacArthur joined the team as the Traditional Knowledge Coordinator in November.

## Preliminary Screenings

This past fiscal year (April 1, 2001 to March 31, 2002) the Board received 220 notifications of Preliminary Screenings. This is a significant increase from 186 received the previous year; and 161 screenings received in the fiscal year 1999-2000.

## Environmental Assessments

The Review Board completed eight environmental assessments this fiscal year and has a ninth on hold due to inactivity by the company. As of March 31, 2002, it had one active environmental assessment going beyond year-end. This is the DeBeers Canada Mining Snap Lake underground mining development.

### Completed in 2000-2001

- Canadian Zinc Corporation's Phase I drilling program; referred October 2000, completed May 2001. (The Phase I drilling and Fuel Cache retrieval were under one land use permit; the Review Board split this into two separate environmental assessments.)
- Patterson Lumber Ltd. timber cutting license application near Pine Point; referred in December 2000, completed September 2001.
- Paramount Resources Bovie Lake and Arrowhead exploratory drilling programs near Fort Liard. The Review Board combined these two referrals into one and it is described as the Paramount Liard East program; referred October 2000, completed September 2001.
- Paramount Resources' Cameron Hills exploratory drilling program in Cameron Hills; referred November 2000, completed October 2001.
- Paramount Resources Gathering System and Pipeline Development; referred April 2001, completed December 2001. This environmental assessment was the first EA done in cooperation with the National Energy Board under the MVEIRB-NEB Memorandum of Understanding signed in December 2000.
- Canadian Zinc Corporation Phase II drilling program; referred April 2001, completed January 2002.

### Environmental Assessments

#### completed; waiting for Ministerial Decision

- Canadian Zinc Corporation's Cat Camp and Fuel Cache Retrieval and Cleanup; referred October 2000, completed May 2001. Ministerial approval still outstanding as of March 31, 2002.
- Canadian Zinc Corporation Decline and Metallurgical Plant; referred April 2001, completed January 2002. Ministerial approval still outstanding as of March 31, 2002.

#### Other

- Robinson's Trucking Ltd. Drybones Bay gravel quarry was initially referred in March 2001 but was put on hold by the Review Board because the company decided not to proceed with the environmental assessment at that time.
- Canadian Forest Oil Ltd. Fort Liard 2D and 3D seismic development; referred in October 2001 but the company withdrew its permit applications before the environmental assessment began.

#### In Progress

- DeBeers Canada Mining Ltd. Snap Lake underground diamond mine development; referred in May 2001.

#### Site Visits

The Review Board made a site visit in July to Snap Lake to see the DeBeers-Canada Mining Ltd. proposed underground diamond mining development.

In August, the Review Board visited Canadian Zinc's Prairie Creek mine site near Nahanni National Park Reserve to see first hand the proposed development which was undergoing environmental assessment.



## Board Activities

Throughout the fiscal year, the Board's members participated in ten board meetings and fifteen teleconferences. The meetings discussed the environmental assessments the Board was responsible for in its third year of operation. In addition, the Board held a community open house in conjunction with its regularly scheduled meeting in Inuvik.

### Strategic Planning

In December 2001, the Board initiated an internal Strategic Planning exercise to determine future priorities. This three-day workshop specifically defined the Mission, Vision and Value statements that are to direct the Board in future operations. A resulting Strategic Planning document set the groundwork for three specific programs: developing a three-year business plan, an expenditure plan anticipating activity surrounding the proposed Mackenzie Valley pipeline application and a work plan for the 2002-2003 fiscal year.

The Board members also developed five key goals for the future:

- To provide leadership in environmental management.
- To establish strong relationships and partnerships with stakeholders.
- To develop and implement environmental impact assessment processes and procedures.
- To enhance the Board's communication with stakeholders.
- To acquire the resources to further develop the Board's capacity.

## Environmental Assessment Guidelines

In September 2001, the Board held a workshop on its revised Guidelines for Environmental Impact Assessment in the Mackenzie Valley with environmental impact assessment practitioners. As a result of this successful workshop, a workplan was initiated for completing the guidelines in cooperation with other stakeholders. The workshop was jointly funded between INAC, the Mackenzie Valley Land and Water Board and the MVEIRB.

The Board revised its draft of the Rules of Procedure for Environmental Assessment and Environmental Impact Review Proceedings. After publishing notification in December's Canada Gazette, the Board formally adopted these rules in March 2002.

The Board also began developing a discussion paper on The Socio-Economic Impact Assessment. This discussion paper will start the process of developing guidelines for the Board to handle this part of its mandate. Developing these socio-economic guidelines will be a public process involving stakeholders.

The Board has a seat on the Cumulative Environmental Assessment Monitoring Framework Committee. Comprised of various government departments and aboriginal organizations, this group has been developing the framework for defining cumulative assessments in the Northwest Territories.

## Review Board Budget

Severe financial restraints, resulting from MVEIRB's shared funding with Claims Implementation, continue to hinder the Board's ability to function. The implementation of a Flexible Transfer Payment system did allow the Board some latitude in carrying over committed funds from one year to another. However, this year's budget allocation from the federal Department of Indian and Northern Affairs was still \$1.1 million, identical to the previous year.

In both August and October, the Chairperson and Executive Director met with the Gwich'in Claims Implementation Committee in Inuvik. The purpose was to discuss the Board's budget and conduct a ten-year review of Claims Implementation.

Currently, Indian and Northern Affairs Canada (INAC) provides supplementary funding to all northern boards who participate in the ongoing work of the Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee. These supplemental funds allow the Board to continue working on this important program without drawing from its core budget.

The Board set up a Finance Committee to assist the staff with the budgeting process and provide ongoing support. Members of this committee are Gordon Wray (Finance Committee Chair), Frank Pope and Todd Burlingame.





## Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee

A meeting organized by the Board in December 2000 brought together the Chairs of the MVEIRB, the Mackenzie Valley Land and Water Board, the Inuvialuit Settlement Area Boards, the National Energy Board, the Canadian Environmental Assessment Agency, the GNWT and INAC for the first time. The purpose of this meeting was to initiate work on coordinating various regulatory and environmental assessment legislations in anticipation of a Mackenzie Valley natural gas pipeline.

The meeting's results were realized in January 2002 with the release of the Draft Cooperation Plan. This document outlines how these diverse bodies may best work together towards success. For 60 days, the Plan was publicly displayed for relevant feedback. After that time, comments were collected, analyzed and incorporated into a final Cooperation Plan. The final document was forwarded to the Minister of Indian and Northern Affairs in April 2002. The Board is also involved in further initiatives arising from the Plan. In January 2002, the Board began negotiations with the Canadian Environmental Assessment Agency to develop a framework for

participation on a review panel, whose concern would be to focus on pipeline applications. In addition, the Review Board is developing a Memorandum of Understanding with the Environmental Impact Review Board for the Inuvialuit Settlement Region; setting the groundwork for joint assessments of various trans-regional projects.

The Board is also involved in developing a set of Common Information Requirements with other northern regulators and the National Energy Board. The requirements would outline the information necessary to complete an application for pipeline projects. The Board began work on this project in January to be continued through the new fiscal year.

Members of the Chairs' Committee met with the Minister of Indian and Northern Affairs, Mr. Robert Nault, in May and December 2001. During this meeting, the members were able to brief Mr. Nault on the progress of the Cooperation Plan, and on other issues of concern to northern boards.

Frank Pope (Board member) of Norman Wells is the Chair of the Northern Pipeline Environmental Impact Assessment and Regulatory Chairs' Committee.

## Other Activities of Interest

### Board Relations Secretariat

INAC hosted a workshop among northern environmental assessment and regulatory boards in November to develop a reference team for the Board Relations Secretariat (BRS). This unit operates within INAC to resolve the administrative and budgeting problems northern boards have faced through their dealings with INAC - Northern Region and INAC - Ottawa. The purpose of the BRS is to provide a one-window point of contact for the boards' communications with the department.

### Transboundary Cooperation Agreements

Board staff discussed cooperation agreements with other regulatory agencies and boards operating adjacent to the Mackenzie Valley. These agreements define the manner by which various agencies are to cooperate in transboundary environmental assessments. Although they may resemble one another, these cooperation agreements are entirely separate and distinct from the Draft Cooperation Plan for the Mackenzie Valley natural gas pipeline. The Board discussed these agreements with the Nunavut Impact Review Board, the Environmental Impact Review Board for the Inuvialuit Settlement Region and with the Alberta Natural Resources Conservation Board.



## Board Training

In April 2001, the Board undertook detailed training in various oil and gas concerns. The training was a joint effort with members of the Mackenzie Valley Land and Water Board. Presentations were made by the Alberta Energy Utilities Board, the Alberta Natural Resources Conservation Board, the Canadian Association of Petroleum Producers (CAPP) and independent consultants. CAPP arranged for visits to oil and gas facilities in the Calgary area to increase Board familiarity with the oil and gas operations.

## Traditional Knowledge

In November 2001, Karen MacArthur joined the Board as its Traditional Knowledge Coordinator. Employed to assist the development of traditional knowledge guidelines for environmental assessments, her work includes organizing a traditional knowledge workshop (part of the consultative efforts to adopt the guidelines, which is planned for the new fiscal year).

## The Next Twelve Months

Throughout the next fiscal year, the Board will continue conducting environmental assessments as they are referred by preliminary screeners. However, since referrals are dependent upon other agencies, it is difficult to predict the precise number of environmental assessments the Board will be responsible for this fiscal year.

The information available to the Board indicates the Mackenzie Delta Producers Group will not be submitting their applications for a Mackenzie Valley pipeline until late in 2003.

Work is continuing on the development of a discussion paper intended to guide the Board's incorporation of section 115 (b) of the MVRMA into its environmental assessment work. This section gives responsibility to the MVEIRB for looking at socio-economic issues.

A Traditional Knowledge In The Environmental Assessment Process workshop is being planned for November 2002. This will help guide the finalization of the Board's traditional knowledge guidelines.

## Notes to Financial Statements

March 31, 2002

### 1. Organization and Jurisdiction

The Mackenzie Valley Environmental Impact Review Board (Board) is established under the Mackenzie Valley Resource Management Act with a mandate to perform environmental assessments in the Mackenzie Valley of the Northwest Territories.

The Board is dependent upon funding in the form of contributions from Indian and Northern Affairs Canada. Management is of the opinion that if the funding was reduced or altered, operations would be significantly affected.

The Board is exempt from income tax under section 149(1) of the Income Tax Act.

### 2. Accounting Policies

The following is a summary of the significant accounting policies used by management in the preparation of these financial statements.

#### (a) Fund accounting

The Board uses fund accounting to segregate transactions between its operating fund and property and equipment fund.

#### (b) Property and equipment

Purchased property and equipment are recorded in the property and equipment fund at cost. Amortization is recorded in the property and equipment fund using the declining balance method, except for leasehold improvements which use the straight line method, at the rates set out in Note 5.

#### (c) Financial instruments

All significant financial assets, financial liabilities and equity instruments of the Board are either recognized or disclosed in the financial statements together with available information for a reasonable assessment of future cash flows, interest rate risk and credit risk.

#### (d) Pension contributions

The Board and its employees make contributions to employee RRSPs. These contributions represent the total liability of the Board and are recognized in the accounts on a current basis.

#### (e) Recognition of contributions

The Board follows the deferral method of accounting for contributions. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and its collection is reasonably assured. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred.

#### (f) Use of estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the updated amounts of revenues and expenses during the period. Actual results could differ from those estimates.

### 3. Budgeted Revenue

## Our Logo

Our new logo has been designed to accommodate the diverse aspects of our role in the Mackenzie Valley and our responsibility to the people, the land and the great waters that course through it. The drum is a strong aboriginal symbol depicting voices of the people, the voices of the board, the land, the animals and the environment. The small circles represent the 28 communities of the Mackenzie Valley ranging in size from the big to small. The change in size also

represents the transition of life for people as they pass from youth to elder, and, for the change in the sun as it passes through the seasons. Curved lines depict the river and the flow of life. Water separates the land and sky. The three lines are the people, the economy and government, our three main influences. We have chosen colours to link us to the other co-management boards in the region. The yellow lines also represent the resources of our land.
