# New INAC Minister visits NWT Board Forum

MVEIRB Chair Gabrielle Mackenzie-Scott, and her fellow NWT Board Forum Chairs met INAC Minister Jim Prentice during the forum's April 20, 2006 meeting in Yellowknife.

Mackenzie-Scott told Minister Prentice about Northerners' passion for the land and their need for a high-quality, responsive environmental assessment and regulatory regime in the NWT. Minister Prentice said his officials will continue to work on improvements with the Board Forum. He stated that he looked forward to working with the Boards.

The Board Forum Chairs told the Minister that:

- Boards lack adequate funding to do the work required
- Boards are concerned about the slow process for appointing new board members
- Board members require training to fulfill their duties

• A lack of land-use plans throughout the NWT is jeopardizing responsive resource management
