Notice of Preliminary Screening Determination for the Thaidene Nëné Wildlife Conservation Area

The Department of Environment and Natural Resources (ENR) has completed the preliminary screening of the referenced application (Project) (attached) based on its mandated responsibilities under Part 5, Section 124 (2) and Section 125 (1) of the *Mackenzie Valley Resource Management Act* (MVRMA).

For the proposed Project, ENR was both the screener and the proponent. The Environmental Assessment and Monitoring (EAM) unit conducted the screening, while the Wildlife and Fish Division was the proponent. During the decision phase, the screener and proponent established a firewall for impartiality.

ENR-EAM is satisfied that:

- The application has been screened pursuant to the MVRMA;
- Reviewers were instructed to submit concerns and comments on whether the proposed Project might:
 - o Cause public concern; or
 - Cause a significant adverse environmental impact.

ENR-EAM has determined that the proposed Project is not a cause for public concern and has no potential to cause a significant adverse environmental impact. Therefore, ENR has decided not to refer the proposed establishment of Thaidene Nëné Wildlife Conservation Area to environmental assessment.

Unless the Mackenzie Valley Environmental Impact Review Board or another party with the authority to do so refers the proposed Project to an environmental assessment, the GNWT will proceed with the next stages of development for the Thaidene Nëné Wildlife Conservation Area after the ten-day pause period has expired.
