**The Government of the Northwest Territories  
comments on the draft Terms of Reference for the Pine Point Mine (EA 2012-01)**

I am writing on behalf of all Government of the Northwest Territories (GNWT) departments. I confirm that all GNWT departments with interests in the Pine Point Mine Project (EA 2012-01) have reviewed the draft Terms of Reference (ToR) issued by the Mackenzie Valley Environmental Impact Review Board (Review Board). Comments and recommendations were provided by the Departments of Environment and Natural Resources; Lands; Education, Culture and Employment; Industry, Tourism, and Investment; and Municipal and Community Affairs.

**Legacy effects**

GNWT recognizes its land management responsibilities in relation to the impacts of past activity at the site. GNWT has initiated discussions with Pine Point Mining Limited (PPML) to discuss current site conditions and possible data collection requirements. The GNWT will file meeting reports during the environmental assessment (EA), as required.

For the information of the Review Board and all parties, the GNWT is submitting a series of documents regarding the history of the site with respect to site conditions and previous remediation efforts. The GNWT will post additional documents as they become available. Parties should note that documents provided that are dated earlier than 2014 do not necessarily reflect current land management responsibilities. At devolution, the GNWT became the primary manager of all land in the Pine Point area, except for the portion of the railbed that is outside of Commissioner's land. The railbed outside of Commissioner's land remains the responsibility of the federal government.

### **Language use in the recommendations section of the ToR**

During a recent meeting with the GNWT, the developer, Pine Point Mining Ltd (PPML) indicated that it will be recommending that the Review Board reconsider the use of “will include” and “must include” in the ToR for some components where the developer believes the information is not required for the EA of the proposed mine.

Specifically, the GNWT understands that PPML will be proposing the replacement of “the proponent will” to wording such as “the proponent should consider” for all the data requirements that PPML believes are not necessary for the EA. GNWT understands PPML’s overall concern and the value of the DAR being focused on necessary data. As PPML has not yet completed its analysis, GNWT is not in a position to provide any additional comments on PPML’s recommendations at this time. Going forward, the GNWT will work with PPML and other parties during the development and technical review of the DAR.

### **Roles and Responsibilities of GNWT Departments in the EA**

The GNWT will participate fully in the EA process, including initiating and responding to any information requests, participating in technical sessions and public hearings, and providing an intervention and closing argument, as invited to do so by the Review Board. Any requests for information intended for a GNWT department regarding the EA, emanating from the Review Board or from a party, should be made to the Project Assessment Branch in the Department of Lands, who will coordinate the GNWT’s responses.

Along with providing expert advice and responding to questions, various GNWT ministers will be responsible ministers under the *Mackenzie Valley Resource Management Act* for this EA. The GNWT will make a final determination regarding which ministers are responsible ministers after the Review Board issues its Report of Environmental Assessment and Reasons for Decision. The GNWT is working with Government of Canada to determine whether the delegation of EA decision-making authorities from the Minister of Northern Affairs to the Minister of Lands will apply for this EA.

The following table provides a summary of the primary roles that relevant departments within the GNWT anticipate performing in this EA. Please note that departments may adjust the nature and level of their participation as information on topics relevant to GNWT mandates and interests becomes available during the proceeding. In areas of shared interests and responsibility, GNWT departments will collaborate with their federal counterparts as applicable.

Education, Culture, and Employment	<ul style="list-style-type: none"> <li>• Will provide specialist advice with respect to education, training, and employment opportunities.</li> <li>• Will provide specialist advice and be involved in EA processes regarding protection and management of archaeological sites.</li> </ul>
