Re: Technical Session August 15-16, 2017

After consulting parties and the developer, the Review Board has scheduled technical session for EA 1617-01 in Behchokò on August 15-16, 2017. If required, the Board will hold an additional day of technical sessions on Thursday, August 17. Parties and their technical advisors are strongly encouraged to attend the technical sessions in person.

The purpose of a technical session is for parties to discuss technical issues with the developer in a face-to-face setting, in order to clearly understand and, where possible, resolve issues. The technical session also facilitates identification of the outstanding issues to focus on during the remainder of the environmental assessment. Pre-technical session conference

A pre-technical session conference will be held on August 1, 2017 in Yellowknife at the Review Board office. The purpose of this conference is to ensure that parties and the developer have a common understanding of the purpose of the technical session and expectations on how to effectively participate. - 1. encourage open discussion between parties and the developer on scientific and traditional knowledge information in an informal setting;
- 2. have focused discussions on project effects that could lead to significant adverse impacts on the environment or people; and
- 3. seek clarification on responses to information requests or other evidence on the public record for the project.

The technical session is informal and will be facilitated by Review Board staff. Review Board members do not attend. Days and times allotted are approximate and may vary during the sessions. If there is time remaining at the end of each day, topics may be moved forward. Parties are reminded to submit CVs or resumes of technical advisors participating on behalf of their respective organizations prior to the technical session.

Technical session logistics:

- Teleconference will be made available to a limited number of participants during the technical session, upon request. However, parties and technical advisors are strongly urged to attend in person. - The technical session will be transcribed, and the Review Board will post verbatim transcripts to the registry.
- An interpreter will be available. If you or the party you represent cannot participate without an interpreter at this technical session, please advise the Review Board by August 10, 2017.

Tips for preparing for and participating in a technical session EA1617-01

The information in this document is based on material in the *Environmental Impact* Assessment Guidelines 2004 and through lessons learned in conducting environmental assessment.

The following tips are meant to assist parties to prepare to participate effectively in the limited time available.

During the technical session, the Review Board encourages parties to:

- focus discussion on significant issues those that matter most to you
- concentrate questioning on project effects that could change components of the biophysical, social, or cultural environment that could lead to significant adverse impacts to the environment or people
- ask questions that will provide you with information on **specifically how** these impacts could occur (that is, the causal mechanism) and how they can be mitigated
- be prepared to discuss how much change you think would be significant and why
- **prepare your questions ahead of time**, and keep them concise so that maximum time can be spent answering and follow-up discussion
- **reference** relevant public registry **documents and page numbers** to provide context to your questions. If you reference other material, be prepared to submit it to the public registry.
