ISSUANCE OF A TYPE "A" LAND USE PERMIT

Attached is Land Use Permit No. MV2001C0012 granted by the Mackenzie Valley Land and Water Board (MVLWB or the Board) in accordance with the Mackenzie Valley Resource Management Act. A copy of this Permit has been filed in the Public Registry at the office of the MVLWB. The MVLWB approved Land Use Permit MV2001C0012 for a period of five (5) years commencing May 5, 2004 and expiring May 4, 2009.

Please read all conditions carefully and note that as per Land Use Permit Conditions 51 through 54, security deposits in the amounts specified in these conditions shall be posted with the Minister and copied to the Board pursuant to Section 71 of the Mackenzie Valley Resource Management Act.

The MVLWB would like to advise De Beers Canada Mining Inc. (DBCMI) that approval should be obtained prior to the use of any municipal disposal or recycling facility for materials generated on-site. The MVLWB would also like to refer DBCMI to the March 22, 2004 letter (attached) from the Government of the Northwest Territories Department of Renewable Resources, which includes comments relating to the disposal of petroleum products.

Please be advised that this letter, with attached procedures, all inspection reports, and correspondence related thereto, are part of the Public Registry, and are intended to keep all interested parties informed of the manner in which the Permit requirements are being met. All Public Registry material will be considered if an amendment to the Permit is requested.

The full cooperation of De Beers Canada Mining Inc. is anticipated and appreciated.
