Directly affected party

A Directly affected party includes a developer, a first nation affected by a proposed development, any responsible minister, a designated regulatory agency or the owner or occupier of any land affected by the development. Any directly affected party, other than the developer, shall notify the Review Board in writing of its intention to participate in the

proceeding. This notice shall indicate the role that the directly affected party intends to play and describe any information that may be provided during the proceeding.

Interveners

A notice of intention to intervene in a proceeding shall be filed with the Review Board in the approved form and within the time specified in the notice published under Rule 2. The notice of intention to intervene shall be in writing and shall clearly state the reason for the proposed intervention, the role that the intervener proposes to play and outline any information that the intervener may provide during the proceeding.8. The Review Board may grant intervener status to an applicant under Rule 7, may request additional information or clarification from any person seeking intervener status and may direct interveners with similar interests to present a joint intervention.
