Dear Luciano Azzolini - Environmental Assessment Officer,

I recently received documents from Michael D. Parrish of Fasken Martineau DuMoulin LLP regarding "In the Matter of an Application for the Renewal of Water Licence N3L2-0004 by North American Tungsten Corporation Ltd." Due to some concerns, I have yet to indicate receipt of the documents by returning the copy of the covering letter to Fasken Martineau DuMoulin LLP.

Concerns:

- I do not have a copy of the November 23, 2002 letter as referenced in the covering letter;

- There appears to be a discrepancy in the series of events noted in a letter dated February 1, 2002 from Udo E. von Doehren - ". . . then renewed covering the period June 29, 1977 to September 29, 1982, slightly overlapping the original licence term; then there was a one-year extension to September 29, 1988. Following a public hearing, there was a further renewal for five years, covering the period September 30, 1983 until . . ."; and

- The right side of the letter dated April 12, 2002 by Chuck Blyth is cut-off.

I trust you also received the documentation - along with covering letter - from Michael D. Parrish of Fasken Martineau DuMoulin LLP. Does your covering letter reference a November 23, 2002 letter? If not, let me know and I will fax you the covering letter sent to me. Can your legal council use this incorrect reference to assist in dismissing the legal challenge?

Please advise if I can be of any assistance in support of dismissing the

legal challenge.
