Dear Sherry,

This is a formal request to change the date of the Public Hearing to the prior week October 2 and 3, 2003. Regardless of the "Procedural Rules," I think there is sufficient time for everyone to get onside for the earlier date.

I make this request because the two days selected, Thursday and Friday October 9th and 10th, 2003 are inconsiderate of the Developers who will have to travel to Yellowknife and will thus have their Thanksgiving Long weekend consumed in travel. It provides no opportunity to further discuss any issues that arise since everyone from the local area will be trying to take an early Friday departure to take advantage of the long weekend.

Personally I had hoped to expand my long weekend with a trip making attendance of the main proponent questionable.

I find again the attitude of the Board in completely disregarding the junior exploration companies concerns or the scope of this project disturbing. Think about it - long weekend; not even a phone call to the main parties; just arbitrary definition!

This process for dealing with a preliminary exploration program has been flawed from day one - for example calling it a development has continued to shape your review of our submissions and request for detail (actual drill site locations) that is only available for an advanced exploration project! - to the arbitrary unilateral nonconsultive extending of timing to now the setting of meetings without even the slightest regard for junior exploration companies.

I really have better things to do!

Please consider the request for changing the date seriously.
