

Dear Mr. Burlingame:

During the week of March 22 to 26, 2004 the NWT Chamber of Commerce Executive visited the communities of Fort Simpson, Hay River, Norman Wells and Inuvik. We were in these communities as part of our annual "Community Tour" to meet with not only the Mayors and Councils, but the members of the regional Chambers of Commerce face-to-face. We have found that these face-to-face meetings allow more impromptu and in-depth discussion about community and Territorial issues.

One of the main discussion points raised in the communities was the proposed Mackenzie Valley Pipeline. Those we spoke with brought up the issues of :

- a) how do local businesses (big or small) prepare to take advantage of the opportunities that the proposed pipeline can bring - who do they talk to?
- b) the location of the Pipeline Readiness Office, the Northern Gas Pipeline Secretariat, the Mackenzie Valley Development Planning division and the Resource Development Task Team members, and
- c) confusion and lack of clarity as to the roles and responsibilities of the various agencies including:
 - a. Mackenzie Valley Environmental Impact Review Board,
 - b. Pipeline Readiness Office DIAND, NWT Region
 - c. Northern Gas Project Secretariat

 - i. Mackenzie Valley Development Planning division
 - ii. Resource Development Task Team
