## Re: INAC Hearing Undertaking – Map

As undertaken during the public hearing for the Consolidated Gold Win Ventures and the Sidon International Resources environmental assessments, Indian and Northern Affairs Canada (INAC) has completed a map of the land use permits, water licences, surface leases, mineral claims and mineral leases in the area south and east of Yellowknife. Please note that the area covered by the map is somewhat larger than was discussed during the questions posed to INAC during the hearing.

The data on the map are current to April 12, 2007. We have also produced a list of the land use permits, water licences, surface leases, mineral claims and mineral leases shown on the map.
