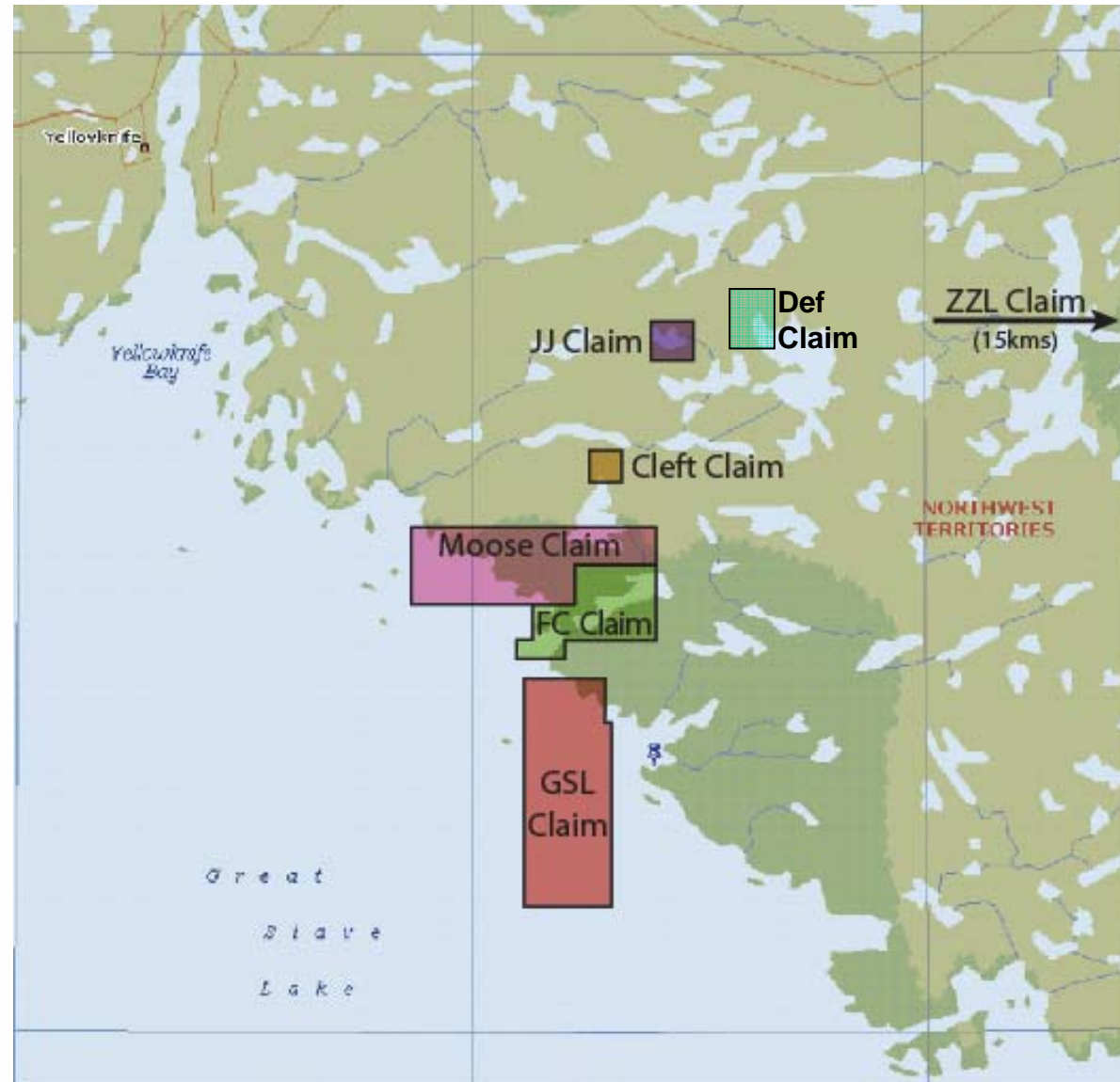

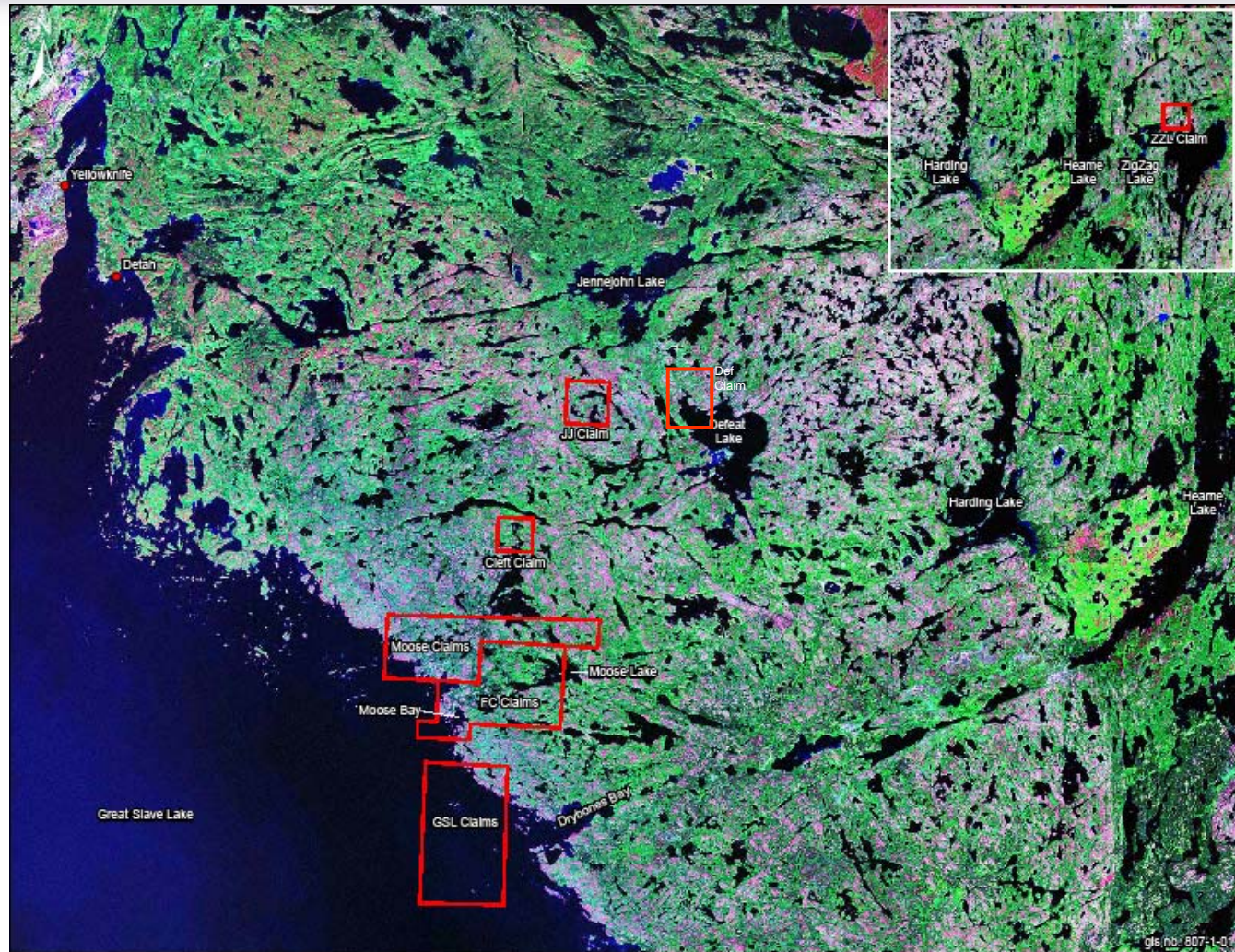

# Project Overview

CONSOLIDATED GOLD WIN VENTURES INC. / SIDON INTERNATIONAL RESOURCES CORP.



- Small winter diamond drilling project
- East side of Yellowknife Bay
- Project timeline: 2-3 months
- Drilling timeline: 3-4 weeks
- Maximum 3 drill holes per claim



# ZZL Claim Area- CGW

- Determine drill targets
  - Magnetic Survey
  - Physical inspection
  - Archaeological survey
  - Consultation with First Nations
  - Site visits with Elders
- Drill cutting disposal
  - On-ice
  - On-land



- **Camp**
  - Moose Bay
  - On-ice
  - 6 person
  - 3-4 weeks
  - Emergency plan in place
- **Sewage and Grey Water Disposal**
  - As recommended by INAC

# Consultation Efforts

CONSOLIDATED GOLD WIN VENTURES INC. / SIDON INTERNATIONAL RESOURCES CORP.



- First Nations groups were contacted in the fall of 2004 and again in 2005 by GeoFin
- Attempts were made by Rescan to consult with the YKDFN in the summer and fall of 2006



- Ensure potential drill locations are not of archaeological or spiritual significance





- Identify sensitive fish habitat
  - Fieldwork will be carried out in the summer months to identify fish habitat, if necessary
  - A bathymetric survey will be conducted, if required
- Mitigation
  - Spawning shoals will be avoided
  - Drilling will only be on areas frozen to the substrate or areas greater than 11 m deep

# Where do we go from here?

CONSOLIDATED GOLD WIN VENTURES INC. / SIDON INTERNATIONAL RESOURCES CORP.



- **Commitment to work cooperatively with First Nations**
  - CGW and SD has hired Rescan Environmental Services
  - Enter into a Memorandum of Understanding with the YKDFN
  - Regular meetings and updates with nominated First Nations representatives
- **Recognition of the cultural, spiritual and historical significance of the area**
  - Archaeological survey with First Nations involvement
  - CGW and SD will access the NWT Archaeological Sites database on an annual basis
  - Adaptive management if additional cultural sites are found
