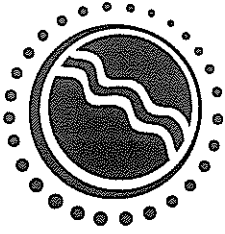

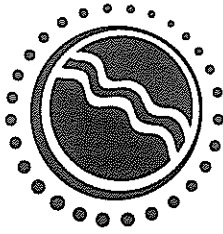
On October 24, the Review Board distributed a notice on the Public Registry setting deadlines for receipt of materials from Parties (Friday, Nov. 2) and the developer (Monday, Nov. 5) for this EA. The Public Record was scheduled to close on Monday, Nov. 5 for this EA.

In the interim, the Review Board has issued IR#55 to the developer, consisting of a list of draft commitments stated by the developer on documents issued to the public registry during the course of the EA. **The deadline for receipt of a response to this Information Request is Friday, November 2, 2007.** Procedural fairness requires that the Review Board provide time for Parties to the EA to assess the developer's response to this IR.

**Therefore, the deadline for receiving materials from Parties has been extended to 5pm MST, Tuesday, November 6, to provide time for any comments on the response to IR#55. The deadline for receiving material from the developer is 5pm MST, Wednesday, November 7, at which point the Public Record will close for this EA.**

Since October 24, the Review Board has received the following material and submitted it to the Public Registry, copies of which are all available on the Review Board website ([www.mveirb.nt.ca](http://www.mveirb.nt.ca)):

1. October 24 - Developer's response to Undertaking #3 from the Public Hearing – wildlife management commitments
2. October 29 – Final analysis from the Deninu K'ue First Nation
