Dear Ms. Mackenzie-Scott,

You asked a question with respect to Deninu Kue First Nation's (DKFN) presentation, "What does DKFN mean by demanding an exploration agreement, when you are not in support of any Uranium development?" In response to this question there is a process that is to take place before any approval or support of every mineral exploration in the Akaitcho Territory. This process is relatively new to Akaitcho Dene First Nation (ADFN), Government and Industry. Any developer or industrial company that applies for an exploration permit within the Akaitcho Territory will be required to sign an Exploration Agreement before it will be reviewed by the Akaitcho Screening Board (ASB). If a company does this, it would show good faith with respect to working with the Dene of Akaitcho.

The reason Deninu Kue First Nation demanded this from UR Energy, is because we need to stand up and begin to use this process. We are not in support of any uranium development nevertheless we still need to compose developer's to recognize the Akaitcho Process.
