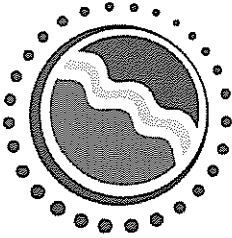

You are hereby notified that Selwyn Resources’ Land Use Permit application (S07C-003) for mineral exploration in the Howard’s Pass area has been referred to Environmental Assessment (EA), pursuant to section 126(2)(b) of the *Mackenzie Valley Resource Management Act*. The project was referred by the Sahtu Secretariat Incorporated.

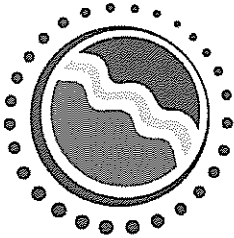
The project is a five-year, lead-zinc mineral exploration drill program, proposed over 24 week periods per summer season. The program is located in the Howard’s Pass area, adjacent to the NWT/Yukon border and 330 km southwest of Tulita, NWT.

As per the requirements of *MVRMA* s.118(1), no license, permit or other authorization required under territorial or federal law for the undertaking of this development can be issued. The Review Board will create a public registry for this file, where all pertinent information will be held. The public registry will be available online at www.mveirb.nt.ca/registry. Details of the assessment process are described in the Review Board’s *Guidelines for Environmental Impact Assessment*, available online at www.mveirb.nt.ca. Information on past EAs is available on the same site.
