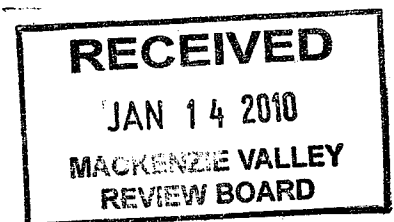

On behalf of Deninu Kue First Nation I strongly feel that inadequate consultation is taking place when the Mackenzie Valley Environmental Impact Review Board (MVEIRB) decided to host the Public hearing for the Deze Energy Taltson Hydro Expansion Project in Dettah, NT on January 14-15, 2010.

It is to my understanding that Ms. Rosy Bjornson, DKFN IMA Coordinator has participated in the pre-hearing conference on December 15, 2009 and thereafter presented the location and venue at our regular band council meeting on January 4, 2010. It is also to our understanding that Rosy did speak to the fact that DKFN does not have the capacity to meet the travel, accommodations, and meals to attend the hearing in Dettah, NT; As well to be able to travel back and forth to Dettah from Yellowknife on both days of the hearing. This does not sit well with us, because the Taltson Expansion project is in our back yard and the public hearing must be held in our community. Our members need to be able to voice their concerns and voice their support for this project.

Therefore as Chief of Deninu Kue First Nation I strongly recommend that a public hearing be held in Fort Resolution, NT to accommodate the Deninu Kue First Nation, Salt River First Nation and Smith's landing First Nation of the Akaitcho Territory Government.
