The Mackenzie Valley Environmental Impact Review Board will host a technical session on May 27-28, 2009 at the Tree of Peace Friendship Centre in Yellowknife, NT. This technical session will be a forum for participants in the environmental assessment of the Taltson Hydroelectric Expansion Project to discuss the Developers Assessment Report and to identify where additional information is needed for the upcoming Information Request submissions. The event is aimed mostly at the parties to the assessment but is open to the public.

The primary goal of the technical session is to identify three categories of issues:

- Issues that have been identified, well-described and resolved in the Developer's Assessment Report
- 2. Issues that have been identified and well-described (requiring no further information to make an accurate impact prediction) but remain unresolved or not mitigated
- 3. Issues that require additional information and are not resolved (may become Information Requests)

The session will follow the format of the Terms of Reference that were issued for this environmental assessment, which are available online here. A draft agenda is attached to this letter and states that Day 1 will focus on the Key Lines of Inquiry as set out in the Terms of Reference and Day 2 will focus on the Subjects of Note. If you have any suggestions or comments on the draft agenda, please forward them to me before Wednesday, May 20, 2009.

Technical sessions are an opportunity to look at the Developers Assessment Report and critically evaluate whether it accurately identifies impacts, appropriately analyzes the significance of those



impacts and whether the developers proposed mitigation is appropriate and effective. By conducting this evaluation in a public forum, participants are able to share ideas and find points of agreement or disagreement, as well as perhaps to resolve outstanding issues or problems with the proposed development. Participants may present evidence that is not contained in the Developers Assessment Report to illustrate their concerns, and this evidence may be scientific or in the form of traditional knowledge or personal experience.
