Please file this e-mail and the attached document on the Giant Mine EA public registry.

Alternatives North has reviewed the organizational chart submitted by AANDC-GNWT on August 10, 2012. We find it to be a confusing mix of functions and what may be individual positions. It is not clear how many staff are or will be located in Yellowknife and what the reporting relationships may be. We intend to ask questions about this new document at the public hearing.

In the meantime, we pulled the government positions for those that would appear to be working on contaminated sites remediation (including Giant Mine) from the Government Electronic Directory Service website. These positions are within AANDC and PWGSC located in Yellowknife, Edmonton and Ottawa.

We would like to confirm which of these staff and positions currently are assigned to Giant Mine on at least a part-time (25% or more) or full-time basis. This is relevant for the environmental assessment in terms of understanding the organization, structure, accountability and responsiveness for the Giant Mine Remediation Project. Thank you.
