### **Request:**

- 1. The definitions used by AANDC for "Aboriginal" and "northern".
- 2. Annual performance figures for the Giant Mine from 1999 to present for:
  - a. Total, northern, northern Aboriginal and southern Aboriginal employment by number of persons and person-hours;
  - b. Total training, northern training, northern Aboriginal training by number of persons and duration (hours); and
  - c. Purchase of goods and services by northern suppliers (including Aboriginal) and northern Aboriginal suppliers by number and \$ expended.
- 3. Proposed targets for the indicators identified in 2 above for the remainder of the Giant Mine Remediation Project.
- 4. Whether and how the Developer intends to report these socio-economic indicators for the Giant Mine on an annual basis.

## Response

The following responses were prepared in response to questions raised by Alternatives North regarding the socio-economic benefits which have accrued to date to both Aboriginals and Northerners as a result of the Giant Mine Remediation Project (GMRP).

Historically, Aboriginal Affairs and Northern Development Canada's (AANDC) Northern Contaminated Sites Program (NCSP) has prepared Annual Performance Reports which among other information detail the socio-economic benefits associated with the NCSP's portfolio of projects. These statistics included those from the GMRP, however, statistics were not presented on a project by project basis but rather as a composite of all projects underway in that year. The responses below highlight only the socioeconomic benefits to Aboriginals and Northerners which have resulted directly from activities associated with the GMRP.





The GMRP realizes the importance of tracking and reporting the impacts on its stakeholders of a project such as this and is in the process of developing its own project specific Performance Measurement Strategy which will include its own set of indicators and targets which will include, but not be limited to, those outlined in the responses below.

This Giant Mine specific Performance Measurement Strategy will form the basis of an annual GMRP Performance Report which will be posted on the internet for ease of access by all stakeholders.

### Response 1

AANDC uses the following definitions:

- Aboriginal person is defined as a First Nation, Inuit and/or Métis person;
- Aboriginal company is defined as a company with a majority (52%) Aboriginal ownership;
- Northern person is defined as a person with permanent residence of greater than six months in any of the three territories; and
- Northern company is defined as a company that has a head office within the three territories.
