Chief Eddie Erasmus went on to say that the TG has considered this decision through the Kwe Beh working group and the Chiefs Executive Council and suggested that further discussions on the Tłıchq TK study should resume after the court announces its decision.	Fortune is prepared to wait until the court renders its ruling and would welcome the opportunity to further discussion on this study.
