- Can't Live Without Work. Prepared by the NSMA in 1999 for the Diavik environmental

 the historic background of the North Slave Métis and the need for Crown Consultation,
 community concerns related to mining and recommended mitigations.
- Socioeconomic Report. Prepared by the NSMA in 2006 for the Diavik Communities
 Advisory Board. Provides community-specific socio-economic data, community
 perceptions (concerns), and recommendations. Many portions are relevant to the
 currently proposed Nico project, especially the recommendations about development of
 more relevant criteria, how to improve the study methodology, and the need for further
 study.
- Socioeconomic Baseline Report. Prepared by the NSMA in 2007 for Gahcho Kue environmental assessment.
