Summary of Discussion:

Representatives from the Government of the Northwest Territories (GNWT) and Avalon Rare Metals Incorporated (Avalon) engaged in discussions and agreed to the following commitments.

Commitments:

- 1. Avalon will comply with the provisions of the *Public Health Act* and Regulations applicable to it and its activities.
- Avalon agreed to provide notification to the GNWT in advance of temporary closures of its Nechalacho Mine and flotation plant sites and/or the hydrometallurgy site. This notification of temporary closures excludes the annual two-week shutdown of the hydrometallurgy plant every summer.
