In response to your letter dated February 11, 2011.

1. A More Detailed Description of Project Impacts on Water, Land, Vegetation and Wildlife

The activities being proposed are very small scale and will have negligible impact on land, water bodies, flora and fauna and communities in the area. Only minor environmental impact is anticipated to the land surface, water bodies, flora and fauna from diamond drilling. Any minimal environmental and resource impact incurred from proposed operation will be very sight specific and short term in nature.

When clearing is unavoidable, it will be carried out in a manor that does not promote erosion. Operations requiring vehicle access, mainly snowmobile or light ATV, or track vehicle will go through areas of smallest vegetation, for example; over rocks and ice on lakes during winter/spring period. The first drill will be made in immediate area of the camp.

2. Description of Expected Water Usage for Camp and Project Operations

We will have between 2 and 3 people to do the work (drilling one hole). This is extremely small scale. We will be using the Snowfield Camp.

The drilling operation will use under 10,000 gallons per day for one drill ahole.

The consumption of water to sustain 3 people would be equal to home consumption, minus the flush toilet.

Each person would use per day approximately:

5 gallons/shower
2 gallons/ drinking
3 gallons/washing
10 gallons/other (food prep & clean up)

Approximately 20 gallons/day/person.

The water is pumped into three holding tanks that hold approximately 300 gallons each.
