Re: EA1314-01 – Jay Project, Developer's Assessment Report review and information request phase

Dominion Diamond Ekati Corporation (Dominion) submitted its Developer's Assessment Report (DAR) to the Review Board on November 6th, 2014. The Review Board conducted an adequacy review of the DAR. On November 28th the Review Board presented Dominion with requirements for further information. This information will enable parties to prepare meaningful and relevant information requests during the next phase of the environmental assessment.

The next step in the environmental assessment of the Jay Project is the parties' review of the DAR and preparation of information requests by parties as well as the Review Board. Information requests and responses are conducted using the Review Board's Online Review System located here: Online Review System

The purpose of an information request is to give parties and the Review Board the information needed to help reach conclusions about potentially significant impacts of the development on the environment and people.

Dominion has indicated to the Review Board that it will respond to the majority of the adequacy items by January 19, 2015 and that it will respond to the remaining items by February 2nd. **Parties are granted two weeks following Dominion's responses to the adequacy review requirements to submit information requests.** The timelines for the review of the DAR and preparation of information requests are as follows:

January 19, 2015 - Dominion submits responses to majority of adequacy review items February 2, 2015 - Dominion submits responses to remaining adequacy review items February 16, 2015 - Parties submit information requests using ORS March 31, 2014 - Dominion submits responses to information requests April 21-23, 2015 - tentative date for technical sessions in Yellowknife

The timing of parties' information request submissions depends, in part, on the timing of Dominion's responses to adequacy review items:

- 1. Please submit any information requests that do not depend on Dominion's responses prior to the due date of Feb. 16th, 2015.
- 2. The majority of Dominion's adequacy review responses will be submitted on Jan. 19th, 2015. Please submit any of your information requests that relate to these responses as soon as possible, and no later than Feb. 16th, 2015.
- 3. Parties will have an additional two weeks after Dominion's final adequacy review responses to prepare and submit the information requests that relate to those responses.
