It is the GNWT's understanding that the Minister of Aboriginal Affairs and Northern Development Canada would sign the final EA decision letter.

GNWT Ministers take actions and provide authorization for permits and licences pursuant to various territorial legislation and regulations. Territorial legislation includes, but is not limited to, the *Environmental Protection Act*, *Waters Act*, *Forest Management Act*, *Forest Protection Act*, *Wildlife Act*, *Northwest Territories Lands Act* and the *Archaeological Sites Act*. GNWT staff from the Departments of Lands inspect compliance with the terms and conditions of land use permits.


