Re: GNWT Response to YKDFN information request #4, map under confidential cover

On May 28 the Review Board received correspondence from the GNWT in response to information request #4 from the Yellowknives Dene First Nation. The correspondence includes a map describing the results of the archaeological survey in the Husky Chedabucto Project area. GNWT requests that the map be kept under confidential cover because it contains sensitive archaeological information. The letter is attached.

The Review accepts GNWT's request to place the map under confidential cover subject to the following terms:

- this Note to File advises parties that the map is under confidential cover
- the May 28 cover letter is attached to this Note to File and placed on the Review Board public registry but the map will not be distributed
- the map will be held under confidential cover at the Review Board office throughout the EA
- parties may make a request to the Review Board to view the confidential portions provided there are legitimate reasons to view it, e.g. a reasonable claim that the party may be affected
- should viewing of the confidential portions be granted by the Review Board, no reproductions in any form will be permitted and the viewing will take place at the Review Board's office only
- the confidential map is available to the Review Board during Board proceedings and decision making
- the confidential map will be returned to the Yellowknives Dene at the end of the EA
