I am writing to inform you that Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) intends to provide participant funding through its Northern Participant Funding Program (NPFP) to facilitate meaningful participation in the Technical Review of the Developer's Assessment Report (DAR) for the Mackenzie Valley Environmental Impact Review Board (MVEIRB)'s review of the Government of the Northwest Territories' Department of Infrastructure's proposed Mackenzie Valley Highway project.
