True North Safaris - General Wildlife Permit Application Review

This letter is to notify you that North Slave Regional Office, ENR has received an application for a permit to bait big game as per Section 17. (1) of the Wildlife Licenses and Permits Regulations According to the Mackenzie Valley Resource Management Act (MVRMA) a Preliminary Screening (PS) will be required. The application was deemed complete on March 17th, 2009 and within 45 days from that date a decision will be made to:

1. Issue a General Wildlife Permit attached with Terms and Conditions,
2. Refer the application to the Mackenzie Valley Environmental Impact Review Board for an environmental assessment, or
3. Refuse to issue the permit along with reasons for the refusal.

Lance following our meeting and discussion today I am including the revisions that you requested.

Please confirm that these are OK.

- When choosing bait sights it is the intention to stay away from publicly used areas and trails so as to minimize any possible negative experiences and dangers for the general public. We will therefore select a number of potential sights that meet the criteria of a minimum distance of 500 meters from public use areas and highways and we will then ask ENR to send a representative along with our company representatives to approve the bait locations before they are established. The maps of these locations will be kept confidential.

We will post signs on the trails leading to the bait sights which will be spaced approximately 50 meters and 150 meter from the baits and if there are more than one trail leading to a bait, they will all be posted in the same manner.

- We will make best efforts to keep diaries and report all bear sightings including information from daily interviews with the clients and game trail cameras.

-We are awaiting the recommendation of a consultant regarding the types of baits that will be used. Generally we want to use a filler like oats and dog food and combine this with attractants, scraps of meat and fish and spray balms and cooking oil and honey burns.

The above provides some clarification to the attached first draft.

> Lance following our phone conversation, I am proposing a meeting with ENR
> Tuesday March17 around 1;00 pm. Lance, please confirm.
>
> Additionally, I am requesting clarification from Rob Marshall as to the
> status of WRRB approval as we have a letter from the Tlicho Government and
> my understanding was that WRRB had already approved this and any concerns
> that they may have will be expressed to ENR to be incorporated into the
> conditions of the permit. Rob can you please advise?
>
> Also the Map and conditions that we had negotiated last year will form
> the
> basis of our request to renew except for the issues that we have
> identified
> that need further negotiation and or change. That this format will then be
> used for future years that all previous conditions will apply unless they
> are re-negotiated.
>
> We are requesting that our area for hunting bears continue to be all of
> unit
> "R" as established by our outfitters license, but the area for
> establishing
> baits be established in the wildlife permit to be the southern boundary of
> the Tlicho land near Mosquito creek to the south side of Birch Creek being
> approximately the North Boundary of the Wood Bison Sanctuary and this year
> we want to include Birch Lake in our area. The eastern boundary to be the
> western shore of GreatSlave Lake and the Western boundary to be 10
> kilometers west of the Mackenzie Highway.
>
> This year we expect to establish 10 to 12 bait sights and we will notify
> ENR within one week of the co-ordinates of each bait sight as we establish
> them.
>
> We expect to start setting up baits at the beginning of May and we will
> remove all of them by the end of June to be stored at the base camp at
> kilometer 170.4
>
> We expect to use metal portable tree stands and to construct some permanet
> wooden stands and to use ground blinds. We expect to continue some spot
> and
> stalk hunting as well as stand and blind hunting.
>
> We want to use all manner of baits including used cooking oil, grains and
> fish and animal parts that are not fit for human consumption.

>
> We will use 45 gallon plastic and metal drums container for the baits as
> well as hanging some from wires and ropes in trees and using some scent
> balms.
>
> We will put up warning signs for the public two each from the directions
> of
> approach one 50 meters and one 150 meters.
>
> The baits will generally be located in clearings so that hunters can
> determine the size and gender of the bears and get clear shots and the
> stands and blinds will generally be back in the trees.
>
> No baits will be closer than 500 meters from any public roads or highways
> or
> parks or camp sites. This does not include old cut lines and wood trails
> that are not maintained for public use nor old quarry sites.
>
> We will generally report all bear sightings by attempting to keep a diary
> of
> the bears sighted each day and submitting a report at the end of the
> season.
> We hope to use some game trail cameras this year. We will provide samples
> as
> ENR may require but will have to arrange for the delivery of these at
> Frank
> Channel or they may be frozen if brought to Yellowknife.

>> o If hunting will utilize stands/blinds, provide a description of the
>> materials to be used in the stand/blind.
